Online ticket purchase inquiries will be contacted for purchasing information (debit payment is acceptable). Just 3,500 raffle tickets are available. Any unsold tickets left at the time of the raffle (approximately 2:00pm CST on July 4, 2023) will be disposed of and not entered into the raffle.
